Right to Education Act

About RTE

The Right to Education (RTE) Act, introduced in 2012 allows children with special needs to pursue mainstream education.

All students, irrespective of their impairment, should be educated in mainstream schools. Disability defined by the Persons with Disability Act 1995 are visual impairment, low vision, **Hearing impairment**, leprosy-cured, loco-motor disability, mental retardation, mental illness, autism, cerebral palsy and multiple disability under section 26 of the PWD Act have the right to study in a regular school environment till the age of 18 years. "The RTE rules for children without disability are till completion of elementary education or class VIII or 14 years of age but for children with disability is till 18 years of age,"

• Reservation Criteria

25% reservation for RTE students

- Disadvantage Group (including Hearing impaired) have 19% seats and 6% for weaker (poor) section.
- Out of 19% reservation, 3% reservation are there in school for each of the seven subcategories (i.e. Locomotor Disability, Blindness, Sight impairment, Hearing Impairment, Autism, Cerebral Palsy, Mental Retardation) under PWD act 1995 of section 2(i) of disability in private unaided and non-minority school comes under RTE Act.
- Tuition fee is reimbursed to the school after admission process is complete.

RTE Admission Eligibility Criteria 2021-22

The **Eligibility Criteria for RTE Admission** (Right to education) is as follows:

- The age eligibility for students with benchmark disability is in between 6 years to 18 years of age.
 - The general rule for admission, the upper age limit is of 5, 6 and 7 years on 31st March for admission in nursery, KG and class 1 respectively. But the minimum age for admission in these classes is 3, 4 and 5 years on 31st March respectively.
- For **Disable categories** are given **one year** age relaxation over those from general category. Upper age limit for applying in all three entry level classes is 8 years as on 31st March.
- For applying the student must be a domicile of India.
- In the case of state-specific application, the student must be a domicile of that state.

RTE Admission Date

The application date for the student willing to apply needs to note that the dates as well as the **RTE Admission Last Date** for all the states fall in between the month of March to May or as announced by the state government.

- Aadhaar card
- Passport size colour photographs
- Caste certificate
- UDID card

Procedure to apply for the admission under RTE

- 1. Please read all the instructions carefully before applying.
- 2. Online form is to be filled on their respective state RTE Portal website.
- 3. The fields marked with * are compulsory.
- 4. Details in the form should be filled carefully and the required documents should be attached with it.
- 5. On the RTE Portal click on "Online Application" tab.
- 6. For first time application click on "New Registration" tab and enter the require details of the child.
- 7. On the registered mobile number they will send username and password.
- 8. Visit RTE portal using that username and password. You can change password. Here 'change password' dialog box will appear and you can enter the new password.
- 9. After changing the password enter again to the RTE portal.
- 10. In first tab (i.e. child) enter all the required details of the child.
- 11. In second tab (i.e. Application) fill the required details of the child and parent.
- 12. In third tab (i.e. School selection) select the school from the list of the school given in it. After selection of the school confirm your details and press on confirm button.
- 13. Intimation of Form confirmation will be sent through SMS/Email to the mobile no/Email Address mentioned in the form.
- 14. Seat allocation intimation will also be sent through SMS on parent's Mobile no. Admit card has to be printed within the time period mentioned on the website. Parent has to approach the allocated school with original documents and take admission within the time period mentioned on the website.
- 15. If you do not approach the school and take admission within the mentioned time period then the form will be considered cancelled.
- 16. If it is found that the documents submitted are not proper then seat allocation will be considered invalid as well as legal procedure as per rules will be done.
