Unique Disability ID Card (UDID Card) Mumbai



About UDID Card

❖ A UDID card is a Unique ID for Persons with Disabilities. Rajya Sabha passed the bill on 14/12/2016 for UDID card. 21 types of disabilities are covered in this act. It is a single document for identification and verification of a disabled person to access various benefits. The card contains all necessary details about a disabled person and bypasses the need for carrying multiple documents.



Benefits of Unique Disability ID Card (UDID Card)

- 1. Application for UDID card can be done online.
- Persons with disabilities will not need to make multiple copies of documents, maintain and carry multiple documents as the card will capture all the necessary details which can be decoded with the help of a reader.
- 3. The UDID Card holder will no longer need to carry lengthy documents as proof of the disability. UDID Card will be acceptable everywhere to prove one's disability condition.

- 4. Using this card will help people with disability to overcome the problems they face regarding the geographical validity of the disability certificate wherever applicable.
- 5. The card will be of a standard credit card size. It will be easy to carry.
- 6. Disability-related data will not get duplicated as the computer system can ensure uniqueness of all the data.
- 7. The system can be easily upgraded if the government wants to do any changes.
- 8. It would be easy to identify the extent of person's disability. A person with less than 40% disability would have a card with a white stripe, 40 to 80% would have a card with yellow stripe and above 80% card with a blue stripe.
- 9. The UDID card will be the single document of identification, verification of the disabled for availing various benefits in future.
- 10. The UDID card will also help in stream-lining the tracking of the physical and financial progress of beneficiary at all levels of hierarchy of implementation from village level, block level, District level, State level and National level.



Who can apply for a UDID card?

- 1. Persons with Disabilities who have any type of disability.
- 2. For Children with hearing loss having loss of sixty decibels or more in the better ear in the conversational range of frequencies can apply for it.
- 3. Persons with Disabilities who already have a Disability Certificate.
- 4. Persons with Disabilities who do not have any Disability Certificate.

- 5. Persons with Disabilities who have applied for Disability Certificate and their Certificate is under process.
- 6. Persons with Disabilities whose certificate are temporary and are in need of re-assessment.
- 7. Persons with Disabilities whose applications were rejected/want to reapply for Disability Certificate and also for re-assessment of percentage.
- 8. All can apply online from anywhere of the India.



Documents required for availing UDID Card

- 1. Scanned copy of the recent color photo. (15kb to 30kb)
- 2. Scanned image of signature/ thumb impression. (3kb to 30kb)
- 3. Scanned copy of Address Proof (Aadhar/PAN Card/ Ration Card etc.) (10kb to 100kb)
- 4. Scanned copy of Identity Proof (Aadhar Card/PAN Card/ Driving License etc.) (10kb to 100kb)
- 5. Scanned copy of Disability Certificate (Issued by the competent Authority) (10kb to 100kb)

Procedure to apply for UDID Card

- 1) To apply online for UDID card visit www.swavlambancard.gov.in.
- 2) In the home page click on "Apply for Disability Certificate and UDID card".
- 3) In first tab i.e., PERSONAL DETATILS fill in the fields marked with "*" (asterisk) (star). Correctly upload the child's photo, Aadhar card, Thumb impression or signature and click on next button.
- 4) In second tab i.e., DISABILITY DETAILS upload the Disability Certificate and fill all the required details of the disability.
- 5) In third tab i.e., EMPLOYMENT DETAILS fill the required details.
- 6) In fourth tab i.e., IDENTITY DETAILS upload the Aadhar card and fill the required details.
- 7) After filling in the form do check all the details again. If you want to EDIT you can click the Edit application tab. (Once you submit you will not be able to edit)
- 8) Once you submit the form you will receive the enrol lment number with your registered mobile number which you need to save for future reference. Take the printout of the receipt.
- 9) All the data will be submitted at the Chief Medical Officer (CMO) Office/Medical Authority for verification.
- 10) The CMO Office/Medical Authority will verify all your data. After verification, the CMO Office/Medical Authority will assign the concerned specialist(s) for assessment. In the receipt list of hospitals is mentioned and visit any one of that hospital for the further assessment.
- 11) Specialist Doctor assesses disability of Person with Disability (PwD) and gives an opinion on disability.

- 12) Medical Board reviews the case and assigns disability percentage. CMO Office prepares Disability Certificate and generates UDID and Disability Certificate.
- 13) UDID datasheet goes for UDID Card printing.
- 14) A message will be sent once the UDID card is ready. Card can be printed from the website.
- 15) After the process UDID card will sent to the address mentioned, by post.
- 16) Once applied, you can check the status of the application by clicking on UDID Card Status on the website mentioned above.



Validity of UDID Card

Validity of the UDID Card is of 5 years in case of temporary disability and for permanent disability validity of it is permanent. If in the card capital "P" is mention it means card is permanent but if in the card capital "T" is mention it means card is valid till 5 years.

- Fill the required details and submit it.

If assessment is done and still not received write an application and go to the hospital with the application and assessment receipt and do the inquiry.
